



OUTLINE OF GGP

Concept of the Grant Assistance for Grassroots Human Security Project (GGP)

- The GGP is a framework that supports NGOs and local public institutions to respond to various development needs in a prompt and precise manner.
- The GGP primarily targets projects contributing to improve Basic Human Needs at the community level, building on the concept of "Human Security".



OUTLINE OF GGP

Concept of Human Security



"Human Security" presents a concept with a focus on individuals, by seeking to promote state and society building through the protection and empowerment of individuals so that they can live with dignity, 'free from fear' and 'free from want'.

OUTLINE OF GGP

Grant Amount

Up to JPY 10,000,000 (e.g., **USD 72,900 in FY 2024**)

Duration of Projects

Up to 12 months

Eligible Applicants

- Local/International Non-Government Organizations (NGOs)
- Local Municipalities
- Public Institutions (including schools and hospitals/clinics)
- > At least 2 years of experience in grant management with stable financial status are required.
- > Higher educational institution (universities/colleges), individuals and private companies are not eligible.

Project Area

- The GGP primarily targets projects contributing to improvement of Basic Human Needs at the community level, building on the concept of "Human Security" within fields of Education, Health, Welfare, Environment, Agriculture, Water and Sanitation, Demining and others.
- The basic concept of GGP is promotion of '<u>hard component</u>' such as provision of equipment and improvement or construction of facilities.
- > A project which includes minor portion of 'soft component' could also be acceptable.






From FY1998 to 2023,

Regional and Sector Distribution of GGP Project in Armenia (FY1998-2023)



APPRICATION INFORMATION – FAQ-

? What kind of projects are not subject to the GGP?

The following are not financed by the GGP : *Projects that propose 'Soft component' activities Commercial activities which have uncertain direct benefits to a community Culture, art and sport projects that are less related to economic and social development.*

? <u>Who is not eligible?</u>

The following are not eligible for the GGP : Central Government and its affiliated organizations International Organizations
Profit Organizations
Individuals. (*XInternational NGOs are eligible*)

? What cannot be covered in the budget?

The following are not covered in principle : Consumables Small fixtures Running and maintenance costs of implementation stage as well as operational stage.

? Does the Embassy of Japan have a tax exempt status?

Yes, tax is exempted in the GGP, thus you are requested to exclude tax amount from the requested budget in the application (**Exception: Although Local Municipalities are eligible for applying, Value-added tax (VAT) is not exempted under the current legislation.**)

? <u>Have you received my application (or e-mail)?</u>
